The Secretary, Linda Palmer, was absent and 1st Vice President, Jeannie Dieffenbach, agreed to perform the duties of recording secretary.

Anna Buchner presented the General Minutes from the September 21, 2010 meeting for approval. The Minutes were approved by the Officers with one correction, and will be included in the newsletter and presented for approval by the General Membership at our next meeting.

Amy Hodgson nominated Lynda Traves as the Newsletter Editor, and Kate Cline seconded the nomination. The appointment of Lynda Traves as the Newsletter Editor was approved by the Executive Committee.


Susan Davis, Parliamentarian, did not have a report.

The meeting was called to order at 12:05 by President Anna Buchner, and a quorum was verified. The officer's in attendance included: President, Anna Buchner; Treasurer, Susan Sunday ACP; and NALA Liaison, Kate Cline ACP. The secretary was absent and Kate Cline ACP agreed to perform the duties of recording secretary. Anna Buchner reminded all her President's Report, the information for today's presentation, and the agenda for the meeting was with the sign-in sheet.

SNAP is still in need of a First Vice President, Newsletter Editor, and a Website Manager. If anybody is interested, feel free to speak to the President after the meeting or send her an email.

The Second Vice President was absent, so there was no report on Membership. The Treasurer's report of the account balances included, General Fund,

seminars, etc. The NALA Liaison reported the study group is continuing with three of the original seven. She asked for assistance with the substantive law areas of Criminal Law and American Legal System/General Law.

An inquiry was made concerning sending an email to SNAP members, and the President noted that matter is specifically covered by the Standing Rules. She requested the information be forwarded to her for review and approval by the EC prior to sending. It was pointed out that the Bylaws and

Standing Rules are on the website, and the members were encouraged to visit the website for that information as well as information on membership renewal, meetings, etc.

Anna Buchner introduced Greg Brower, former US Attorney and now with Snell & Wilmer, who discussed Ballot Ouestions No. 1 and No. 2 for the November 2010 ballot. As to Ouestion No. 2, Mr. Brower noted that this is the third time this initiative (or similar) has been placed on the ballot. He pointed out that approval by the voters of this initiative only authorizes the Legislature to establish the appellate court system. Mr. Brower next addressed Question No. 1, noting that this appears to be the more controversial of the two. Mr. Brower reviewed the discussion/ explanation of why each question was

proposed, and the pros and the cons for each of the two questions. Considerable discussion and questions by the attendees ensued.

There being no further business, the meeting was adjourned at 1:05 p.m.
