## President's Note

Over the years I have been asked how I got my start in the paralegal professional. I have fond memories of those days.

During the late 1970's and 1980's I was in banking. I enjoyed banking because I worked with people, was good at numbers, and was detailed oriented. In the late 1980's banking changed. It became sales oriented which required me to cold call potential customers. Sales is not my forte, and I knew it was time for a career change.

During a conversation with an acquaintance, she suggested the growing field of paralegals. I did some research and learned that might be something for me. It was 1988, and the only school in Reno with a paralegal program was Reno Business College, now known as Morrison University. I met with the admissions officer and signed up that day.

Within a few months of starting school, I decided to leave my banking career and begin my paralegal career. I was in for a surprise. After several interviews I learned no one wanted to hire me because I had no experience. How did I get experience? I started as a legal receptionist and secretary to the two investigators in the office. Although the pay was low, I was surrounded by people in the legal field. The legal secretaries in the office took me under their wing, and I was eager to learn. In addition to performing my other duties, the legal secretaries let me assist them by drafting simple letters and indexing pleadings. Not much, but it was a start.

After one year as a legal receptionist and the majority of my coursework completed, I knew it was time to move on. Fortunately Ken Bick was looking for a paralegal he could train. He took a chance on me, and I was a quick learner. I worked for him nine years.




For October, Rebecca Gasca, Legislative and Policy Director, ACLU of Nevada Will be presenting "Know Your Rights."

Rebecca has asked if our association has a specific ACLU issue. If so, the sooner we let her know the better, as she said she will do some extra work on the history and context. If not, it will be a general discussion on civil rights and what to do if they are violated. So, please contact Melissa Paschal with a specific topic for Rebecca to address.

For November, Dr. Larry Pinson will be our speaker. He is a graduate of the University of California at San Francisco in 1973, practiced pharmacy for 32 years prior to being selected for the position of Executive Secretary of the Nevada State Board of Pharmacy. He owned and operated


his own pharmacy, Silverada Pharmacy, in Reno for 22 years after practicing clinical pharmacy at St. Mary's Hospital for 5 years.



During his tenure as Board President, the Board developed and implemented one of the first controlled substance abuse prevention task forces in the nation to combat 'Dr. shopping" and improper prescribing practices in Nevada. Under his direction, the Board initiated an "inspection for safety" program to better ensure safe

pharmacy practices in Nevada. He has held an adjunct professorship for Idaho State University since 1989, and serves as a preceptor for pharmacy students for both North Dakota State University and Creighton University.

Besides serving as a consultant pharmacist and committee member for numerous facilities and organizations over the years, he currently is the President of the Alumni Association for UCSF. Dr. Pinson received the Bowl of Hygeia for the state of Nevada in 1984 and was selected "Pharmacist of the Year" by the state association in 1999.
